In exercise of the powers conferred by Rule 6 of the Pondicherry Institute of Linguistics and Culture (PILC) Rules and Regulations, the Governing Body hereby makes the following rules regulating the method of recruitment to Group 'C' and Group 'D' posts in the Institute, namely:-

1.(i) Short title and commencement:

approval by the Governing Body.

2. Number. of post, its classification and scale of pay:-

The number of the post, its classification and the scale of pay attached there to shall be as specified in coloumn 2 to 4 of the Schedules anneaxed here to.

3. Method of recruitment, age limit and other guraifications:-

The method of recruitment to the said posts, age limit, qualifications, and other matters relating thereto shall be as specified in coloumn 5 to 12 of the said schedules, the crucial date for determining the age limit shall be the closing date for receipt of applications from candidates.

In respect of posts the appointments to which are made through the Empoyment Exchange the crucial date for determining the age limit will, in each, be the last date upto which the Employment Exchange is asked to sponsor names.

4. Disgualification: - No person -

a) Who has entered into or contracted a marriage with a person having spouse living; or

- b) Who, having a spouse living, has entered into or contracted a marriage with any person shall be eligible for appointment to the said post; provided that the Governing Body may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and there are other grounds for so doing exempt any person from the operation of this rule.
- 5. Power to relax:-

Where the Governing Body is of the opinion that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in writing relax of the provisions of these rules with respect to any class or category of persons.

6. Saving:-

Nothing in these rules shall affect the reservations, relaxations in upper age limit and other concessions required to be provided for the scheduled castes, the scheduled tribes and other category of persons in accordance with the orders issued by the Government of Pondicherry from time to time in this regard.
